A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, ESTABLISHING RATES FOR OFF-DUTY DETAILS FOR PUBLIC SERVICE AIDES; PROVIDING FOR CONFLICT; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 2-400 of the City Code provides that the City Commission shall establish rates for off-duty detail services and fees for the city's administrative expenses;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The following rate is hereby established for public service aide details:

	<u>Previous Rate</u>	<u>Amended Rate</u>
Public Service Aides	\$18.50 per hour	<u>\$19.50 per hour</u>

Section 2. Conflict. All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 3. Effective Date. This Resolution shall be retroactive to October 1, 2009.
