A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING A REQUEST TO PERMIT CONSUMPTION OF ALCOHOL AT A SPECIAL EVENT AT MARKHAM PARK ON NOVEMBER 8, 2009, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Section 3-2 of the City Code prohibits the consumption of alcoholic beverages in any public park unless special permission is obtained from the City Commission ; and

WHEREAS, on September 21, 2009, the City Commission approved Resolution 09-170, authorizing Mr. Sydney Roberts, to host an all-day special event known as the "Jamaican Jerk Festival" at Markham Park on November 8, 2009 with a maximum daily attendance capacity of 20,000 persons; and

WHEREAS, Mr. Roberts has now requested City approval to file an application for a Temporary One Day Permit Alcoholic Beverage License with the State of Florida; and

WHEREAS, the City Manager has reviewed this application along with the recommendations of staff and concurs with granting this approval;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. Applicant, Sydney Roberts, is hereby granted special permission to apply for a Temporary One Day Permit Alcoholic Beverage License for an all-day special event known as the "Jamaican Jerk Festival" at Markham Park on November 8, 2009.

Section 2. The Community Development Department is hereby authorized to execute all necessary documents in conjunction with granting a Temporary One Day Permit Alcoholic Beverage License.

Section 3. Effective Date. This Resolution shall be effective immediately upon its passage.
