







SUMMARY EXPLANATION/BACKGROUND INFORMATION/JUSTIFICATION:

IT IS RECOMMENDED THAT AN ADDITIONAL TWO (2) PAY STEPS BE ADDED TO THE SALARY RANGE FOR THE CLASSIFICATION OF POLICE CAPTAIN AND THE CLASSIFICATION OF DEPUTY POLICE CHIEF. THIS RECOMMENDED SALARY RANGE CHANGE WOULD INCREASE THE SALARY RANGE MAXIMUM FOR POLICE CAPTAIN FROM \$111,827 TO \$117,488 (FROM STEP PC77 TO PC79), AND FOR THE DEPUTY POLICE CHIEF FROM \$119,233 TO \$125,269 (FROM STEP E80 TO E82). INCUMBENT EMPLOYEES IN THESE CLASSIFICATIONS WOULD BE ELIGIBLE FOR A ONE (1) STEP INCREASE UPON ADOPTION OF THIS RESOLUTION. WHILE SALARY COMPARISONS WITH OTHER BROWARD POLICE AGENCIES WERE CONSIDERED, THESE CHANGES ARE BEING RECOMMENDED BASED UPON SALARY COMPACTION CAUSED BY SALARY INCREASES GRANTED TO SUBORDINATE POLICE CLASSIFICATIONS.



A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, PURSUANT TO ORDINANCE 715-X, AS AMENDED, TO PROVIDE FOR A REVISION IN THE SALARY RANGE FOR POSITIONS WITHIN THE POLICE EXECUTIVE/MANAGEMENT PAY PLAN APPENDIX; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Section 2(J) of Ordinance No. 715-X, as amended, provides for amendment by resolution of certain schedules and appendices contained in the ordinance;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. The pay plan as set forth in Appendix "A" "Pay Range" is amended, as follows:

Deputy Police Chief	<u>69-82</u>	<del>67-80</del>

Section 2. Effective upon the passage of this Resolution, eligible incumbents within the positions identified above shall advance to the next step.

Section 3. Effective Date. This Resolution shall be effective immediately upon its passage.
