A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, APPROVING THE APPLICATION OF SYDNEY ROBERTS TO HOST A SPECIAL EVENT AT MARKHAM PARK ON NOVEMBER 8, 2009, AND TO ESTABLISH A MAXIMUM DAILY ATTENDANCE CAPACITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Code requires that applicants wishing to host an all-day special event at Markham Park, where the maximum daily attendance capacity is expected to exceed 15,000 patrons, receive City Commission approval via Resolution for the event and that a maximum daily attendance capacity allowed be established; and

WHEREAS, Sydney Roberts has made application to the City for approval to host a "Jamaican Jerk Festival" with a maximum daily attendance of 20,000 persons scheduled to be held on November 8, 2009; and

WHEREAS, the Building Department has confirmed that the applicant has submitted all of the required paperwork and secured all necessary permits from the Building Department, and other agencies, and the Building Department recommends granting approval of this special event application with a maximum daily attendance of 20,000 persons; and

WHEREAS, the Police and Fire Departments have reviewed this application and agree that the applicant has demonstrated that all provisions of the Code have been met with regard to sufficient traffic management, fire safety and public security measures, and recommend granting approval of this special event application with a maximum daily attendance of 20,000 persons; and

WHEREAS, the City Manager has also reviewed this application along with the recommendations of staff and concurs with granting this approval;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. Applicant, Sydney Roberts, is hereby authorized to host an all-day special event known as the "Jamaican Jerk Festival" at Markham Park on November 8, 2009 with a maximum daily attendance capacity of 20,000 persons.

Section 2. The Police and Fire Departments are hereby authorized to, and shall ensure, that all necessary action to protect safety and security at the event will be taken, notwithstanding the maximum daily attendance capacity.

Section 3. Effective Date. This Resolution shall be effective immediately upon its passage.
