



**RESOLUTION NO.**

A RESOLUTION OF THE CITY OF SUNRISE, FLORIDA, PURSUANT TO ORDINANCE NO. 715-X-98-A, AS AMENDED, PROVIDING FOR A MERIT INCREASE FOR GENERAL EXECUTIVE/MANAGEMENT, GENERAL SUPERVISORY/PROFESSIONAL, AND POLICE EXECUTIVE/MANAGEMENT POSITIONS OF THE CITY OF SUNRISE; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SUNRISE, FLORIDA:

Section 1. Pursuant to Ordinance No. 715-X-98-A, as amended, each General Executive/Management, General Supervisory/Professional, and Police Executive/Management employee is eligible to receive a merit increase of two and one-half percent (2½%) on his or her next anniversary date during the 2009/2010 fiscal year. Employees may not advance beyond their pay range except for longevity pay.

Section 2. Effective October 1, 2009 each Fire Executive/Management employee is eligible to receive a double step (5%) merit increase on his or her next anniversary date during the 2009/2010 fiscal year. Employees may not advance beyond their pay range except for longevity pay.

Section 3. Funding for this resolution shall be from the various departmental accounts.

Section 4. Effective Date. This Resolution shall be effective immediately upon its passage.
