ORDINANCE NO. _____

AN ORDINANCE OF SPECIAL TAX DISTRICT NO. 1 OF THE CITY OF SUNRISE, FLORIDA, ADOPTING A BUDGET FOR THE 2009/2010 FISCAL YEAR BASED UPON THE ESTIMATE OF REVENUES AND REQUESTED APPROPRIATIONS AS SUBMITTED BY THE EXECUTIVE DIRECTOR; PROVIDING FOR CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the estimates of revenues and requested appropriations for Sunrise Special Tax District No. 1 for the fiscal year commencing on October 1, 2009, and ending September 30, 2010, have been prepared by the Executive Director and submitted to the Board of Supervisors as required by the District Charter; and

WHEREAS, public hearings on the fiscal year 2009/2010 budget have been advertised and conducted pursuant to law;

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF SPECIAL TAX DISTRICT NO. 1 OF THE CITY OF SUNRISE, FLORIDA:

Section 1. Budget Adoption. The estimate of revenue and requested appropriations for the fiscal year 2009/2010 for Special Tax District No. 1, as set forth in the annual budget attached to and made a part of this Ordinance as Exhibit "1," are hereby adopted.

Section 2. Creation of New Line Items. The creation of new budgetary line items may be permitted by resolution of the District Board of Supervisors.

Section 3. Conflict. All ordinances or parts of ordinances, all City Code sections or parts of City Code sections, and all resolutions or parts of resolutions in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 4. Severability. Should any provision of this Ordinance be declared by a court of competent jurisdiction to be invalid, the same shall not affect the validity of the ordinance as a whole, or any part thereof, other than the part declared to be invalid.

Section 5. Effective Date. This Ordinance shall be effective immediately upon its passage.
