

Scope of Work

- **Hiatus Road from Sunrise Blvd. to Oakland Park Blvd.**
- **Road Closures**
 - NW 20th Court (Gate) NW 26th Place (Gate)
 - NW 21st Street NW 27th Street (Gate)
 - Sunset Strip NW 27th Place (Gate)
 - NW 25th Court NW 28th Street
 - NW 26th Street (Gate) NW 32nd Place
- **NW 29th Manor remains connected (Fully Signalized)**
- **Hammerhead Street Closures**
- **Wall Construction**




Wall Construction
