Re: Political Signs Policy for Polling Places on Public or Private Property - REVISED

Section 16-253 of the Land Development Code governs the placement of political signs in Residential and Non-Residential Districts. For Residential Districts; one political sign per lot is allowed with a maximum area of eight (8) square feet that may be placed sixty (60) days prior to an election and up to fourteen (14) days after an election. For Non-Residential Districts; one political sign is allowed per lot with a maximum area of thirty-two (32) square feet that may be placed sixty days (60) days prior to an election and up to fourteen (14) days after an election. Section 16-254(f)(2) prohibits signs on any right-of-way or public sidewalk. The Code does not specifically address additional political signage for polling places. The Code does not allow persons to post any signage on City property.

The City of Sunrise currently has ten (10) polling sites on City property, seven (7) polling sites on Broward County property, and several polling sites on private property. To further the compelling governmental interest of allowing ample election-oriented speech in connection with an election polling place, a policy is needed to provide for the ability to have additional political signs at these polling locations during the time that they are used as polling places, over and above what the City's sign code would normally allow. A current list of polling sites is listed below. The City shall refrain from enforcement of Section 16-254(f)(2) for political signs at polling sites and on the right-of-way immediately adjacent to those polling sites, provided the political signs conform to the following:

1. Candidates shall be entitled to install no more than one political sign at each polling site within the City.
2. If the polling site is not City-owned, the candidate must receive the permission of the property owner.
3. The political sign shall have a maximum area of six (6) square feet.
4. The political sign shall not be placed on the site being utilized as a polling site more than two (2) days prior to the date of the election.
5. The political sign shall be removed from the polling site no more than two (2) days after the election.
6. The political sign shall not be placed within one-hundred (100) feet from the polling site building entrance and no more than three hundred (300) feet from the polling site building entrance. At no point shall any political sign obstruct the sight visibility of any vehicle within any roadway, driveway, or right of way.
7. Signs must comply with all applicable state and federal laws.
